CHC43315 Certificate IV in Mental Health (CRICOS Course Code: 114061F)

Qualification Description

This qualification reflects the role of workers who provide self-directed recovery oriented support for people affected by mental illness and psychiatric disability. Work involves implementing community based programs and activities focusing on mental health, mental illness and psychiatric disability. Work is undertaken in a range of community contexts such as community based non-government organisations; home based outreach; centre-based programs; respite care; residential services, rehabilitation programs; clinical settings; or supporting people in employment. Work is carried out autonomously under the broad guidance of other practitioners and professionals.

To achieve this qualification, the candidate must have completed at least 80 hours of work as detailed in the Assessment Requirements of units of competency.

Career pathways may include, but are not limited to:

- Coordinator Mental Health (Carer Peer Work)
- Coordinator Mental Health (Consumer Peer Work)
- Community Rehabilitation Worker
- Community Rehabilitation and Support Worker
- Outreach officer
- Mental Health outreach worker
- Assistant community services worker
- Family support worker

Employment pathways from the Qualification

Graduates of the CHC43315 Certificate IV in Mental Health are most often employed as:

- 58.9% Community and Personal Services Workers.
- 16.0% Professionals.
- 9.7% Clerical and Administrative Workers.

No licensing, legislative or certification requirements apply to this qualification at the time of publication.

Course Entry Requirements

Whilst there are no entry requirements specified in the training package, the RTO requires prospective learners to meet the following course entry criteria:

- Applicants must be minimum 18 years of age at the time of commencement
- Applicants must demonstrate that they have attained at least ACSF level 3 by successful completion of Australian Year 12 qualification, or equivalent
- Have obtained an IELTS band score of at least 6.0 or equivalent; or 5.5 where the test score is combined with at least 10 weeks ELICOS or 5.0 where the test score is combined with at least 20 weeks ELICOS; or,
 Reference (Subclass 500 Student visa (homeaffairs.gov.au)
- Have completed a Certificate III, IV, Diploma or Advanced Diploma level Qualification in Australia; or,
- Have completed Certificate III or Certificate IV in ESL or EAL from the ESL/EAL or,
- Have completed the ELICOS Course: General English Intermediate Level.

Alternatively, students may demonstrate the required ACSF and LLN levels by undertaking Howland Academy of Australia's ASCF LLN assessments.

Resources & Facilities

In addition, Howland Academy of Australia requires that the learners:

- have a Children Check and/or Police Check (In Australia) prior to the work placement if request by the host employer(s);
- must be able to work with various types of clients such as different age group from 18 years and above, different religious believes, different nationalities.
- should have basic computer skills including using MS Office software or other spreadsheet, and word processing software;
 and,
- have a personal computer, laptop, tablet or any device, with access to MS Office application packages (At least MS Excel, MS Word and MS Power Point).
